



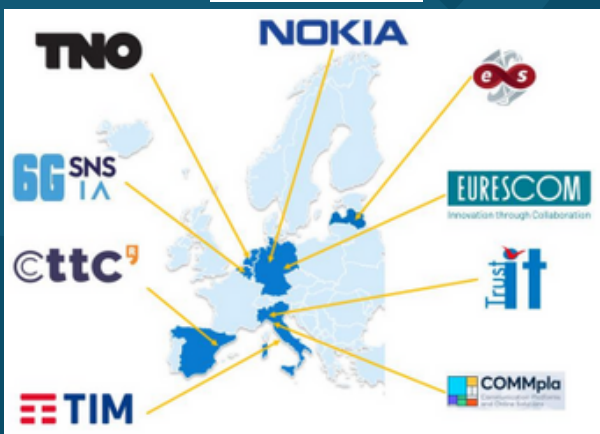
Significant activity is being progressed to create a collaborative environment for European and global stakeholders involved in the preparation of 6G smart networks and services.

Planning and organization for future events is ongoing, it includes events like 5G Techritory, 10th Global 5G Event, IEEE Future Networks World Forum (FNWF) 2023, IEEE Globecom etc.

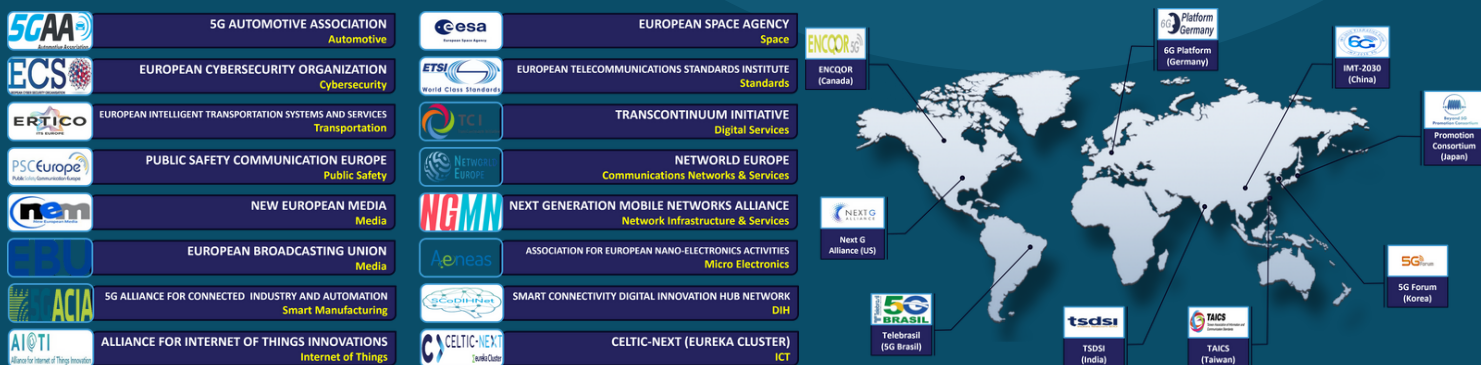
CONSORITUM



SNS ICE project has been operational for six months (since 01/01/2023) and all 9 partners have been actively engaged with the project activities, working together towards the common goal of the project to become the International, European and Vertical-oriented ambassador of the SNS JU programme.

HIGHLIGHTS OF THE FIRST 6 MONTHS

- The project partners have organization and participation in 8 International events, 8 European events and 5 Vertical oriented events in form of Presentations, key-note address, workshops, Co-creation sessions, Panel discussions etc.
- The project has successfully established communication links with more than 24 International stakeholders including IMT-2030 (5G) & (6G) Promotion Group - China, 5G Forum (Korea), 5G MF (Japan), 5G Americas, Telebrasil - Projeto "5G Brasil", ENCQOR (Canada), TSDSI (India), Beyond 5G Promotion Consortium - Japan, Next G Alliance - North America, Trade and Technology Council (EU-US), Industry Technology Research Institute (ITRI) Taiwan.
- SNS ICE has established connections with more than 30 European stakeholders and 6 National Initiatives including Key Digital Technologies (KDT), High Performance Computing (HPC), Photonics 21, AI, Data and Robotics, CCAM Association, DIH, Sub-networks, CELTIC-NEXT, AENEAS, GSMA (Regulation, Events), Small Cell Forum (Small Cells), 6G platform Germany etc.
- More than 10 Vertical stakeholders/ Associations are connected with SNS ICE consortium. This includes 5GAA (Automotive), ERTICO (Transport systems and services), ECSO (Security), PSCE (Security), NEM (Media), EBU (Media), 5G-ACIA (Manufacturing), UIC (Railways), EUTC (Utilities), ECHalliance (Health) and/or 5G Health Association etc.
- Communication links with other related Strategic projects like 6G START, SNS OPS and Hexa-x-II are established, enabling synchronization on activities and task delegation.
- Identification of approximately 100 national 6G projects based on National EU Initiatives.
